### **SECTION 4 : FIRST AID MEASURES**

As a general rule, in case of doubt or if symptoms persist, always call a doctor.

### 4.1. Description of first aid measures

### In the event of exposure by inhalation :

In the event of massive inhalation, remove the person exposed to fresh air. Keep warm and at rest.

### 8.2. Exposure controls
