SECTION 2 : HAZARDS IDENTIFICATION

2.1. Classification of the substance or mixture

SECTION 4 : FIRST AID MEASURES

4.1. Description of first aid measures

In the event of exposure by inhalation :

In the event of massive inhalation transport the patient to the free air and keep it with the heat and rest.

In the event of splashes or contact with eyes :

Wash thoroughly with soft, clean water for 15 minutes holding the eyelids open.

Address the subject at a ophthalmologist, in particular if it appears a redness, a pain or a visual embarrassment.

In the event of splashes or contact with skin :

Remove contaminated clothing and wash the skin thoroughly with soap and water or a recognised cleaner.

Watch out for any remaining product between skin and clothing, watches, shoes, etc.

If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.

In the event of swallowing :

Seek medical attention immediately, showing the label.

DO NOT induce vomiting. Keep at rest.

Personal protection measures, such as personal protective equipment

Use personal protective equipment that is clean and has been properly maintained.

11.1. Information on toxicological effects
