SECTION 4 : FIRST AID MEASURES

4.1. Description of first aid measures

In the event of exposure by inhalation :

In the event of vapor inhalation, fog or fume causing irritation, withdraw the subject of the exposed zone and to place it at the fresh air.

In the event of splashes or contact with eyes :

Wash thoroughly with soft, clean water for 15 minutes holding the eyelids open.

If there is any pain, redness or visual impairment, consult an ophthalmologist.

In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor. Seek medical attention, showing the label.
