Given DEBIO F's flash point, it can be used on hot surfaces and in hot weather.

DEBIO F is emulsifiable and can therefore be diluted (preventive effect, HP rinsing...) if the frequency of application allows.

Debituminising public works equipment and vehicles:

Apply DEBIO F undiluted (by spraying) and leave for 30 minutes. Rinse with pressurised water.

Cleaning application :

Apply DEBIO F undiluted to soiled surfaces, Leave for 30 minutes. Rinse with pressurised water.

Anti-stick:

Apply DEBIO F undiluted or diluted to the surfaces to be protected. (Dilute 20 to 30% in water), Repeat if necessary. Avoid prolonged application on paints or certain flexible hoses, rubber boots, etc. and preferentially use ANTICOL F (C332F).
